The audio files will then be transmitted to the Microsoft Azure cloud environment in the United States for transcription processing.
- Processing of Audio Files: In the Microsoft Azure cloud environment, the audio files will be processed to generate a text-based transcript. The processing adheres to Microsoft Azure's security protocols to ensure data confidentiality and integrity.

Data Retention and Deletion:

- Audio Files: After processing, the audio files are promptly deleted from the cloud environment and are not retained by Microsoft Azure or Elevate Healthcare.
- Transcription Data: The completed transcription will be returned to your LearningSpace instance. Once the transcription is successfully delivered, it will also be deleted from the cloud environment.
